WHAT IS GTIB?



Created by the Georgia Legislature in 2010, the Georgia Transportation Infrastructure Bank (GTIB) is a grant and low-interest loan program administered by the State Road and Tollway Authority (SRTA).

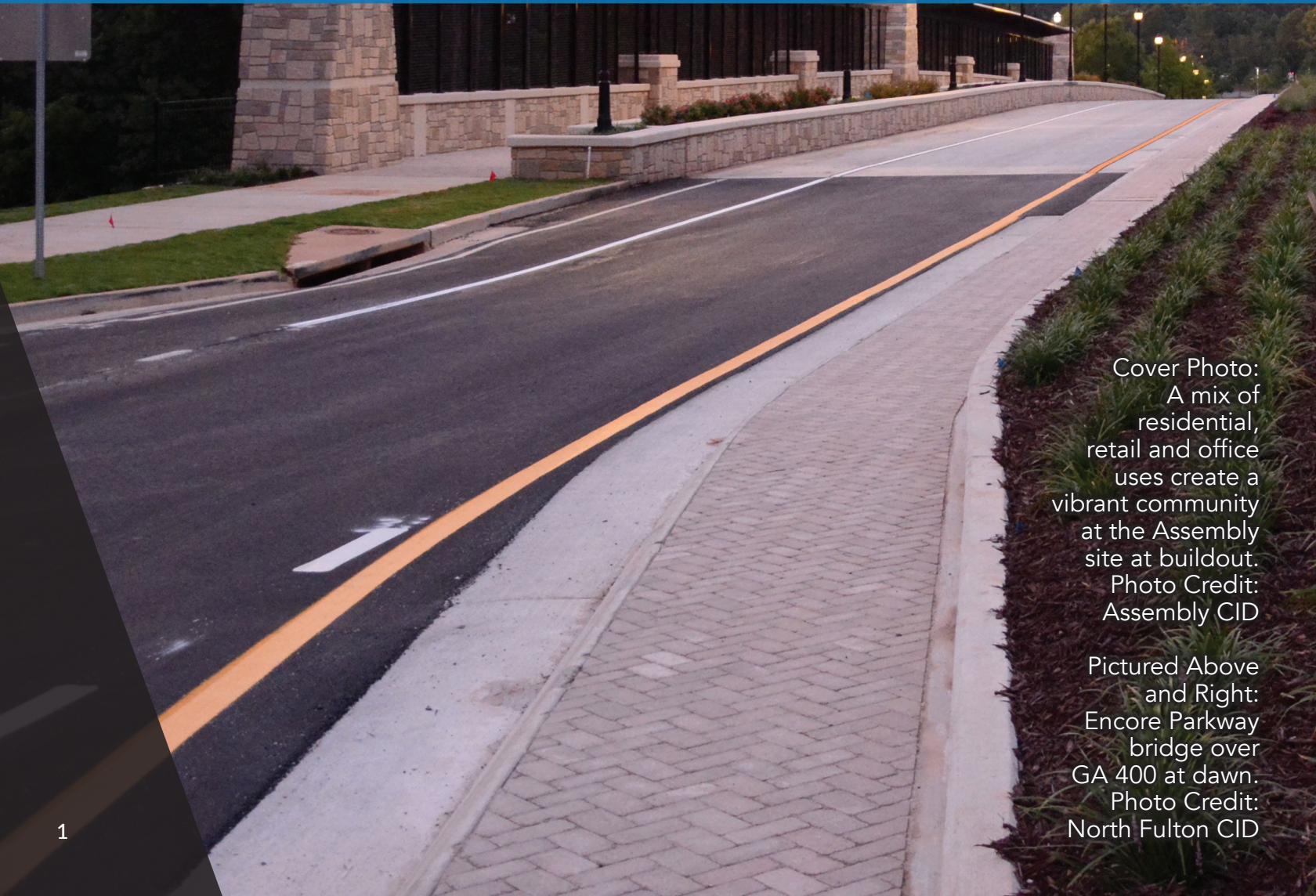


Since its inception, GTIB has provided \$125 million in grants and loans to highly competitive transportation projects. This investment has resulted in \$770 million in total transportation infrastructure investments.



GTIB invests in projects that address critical local and state transportation needs including **economic development** and **mobility**, demonstrate a high degree of **local commitment** and include **innovative solutions**.

This report features projects that reflect GTIB investment objectives and details the most recent round of GTIB funding.

South Barrett Reliever Phases 2 & 3

Year of Awards: 2014 & 2017, respectively

Project Status: Phase 2 completed 2018 and Phase 3 underway

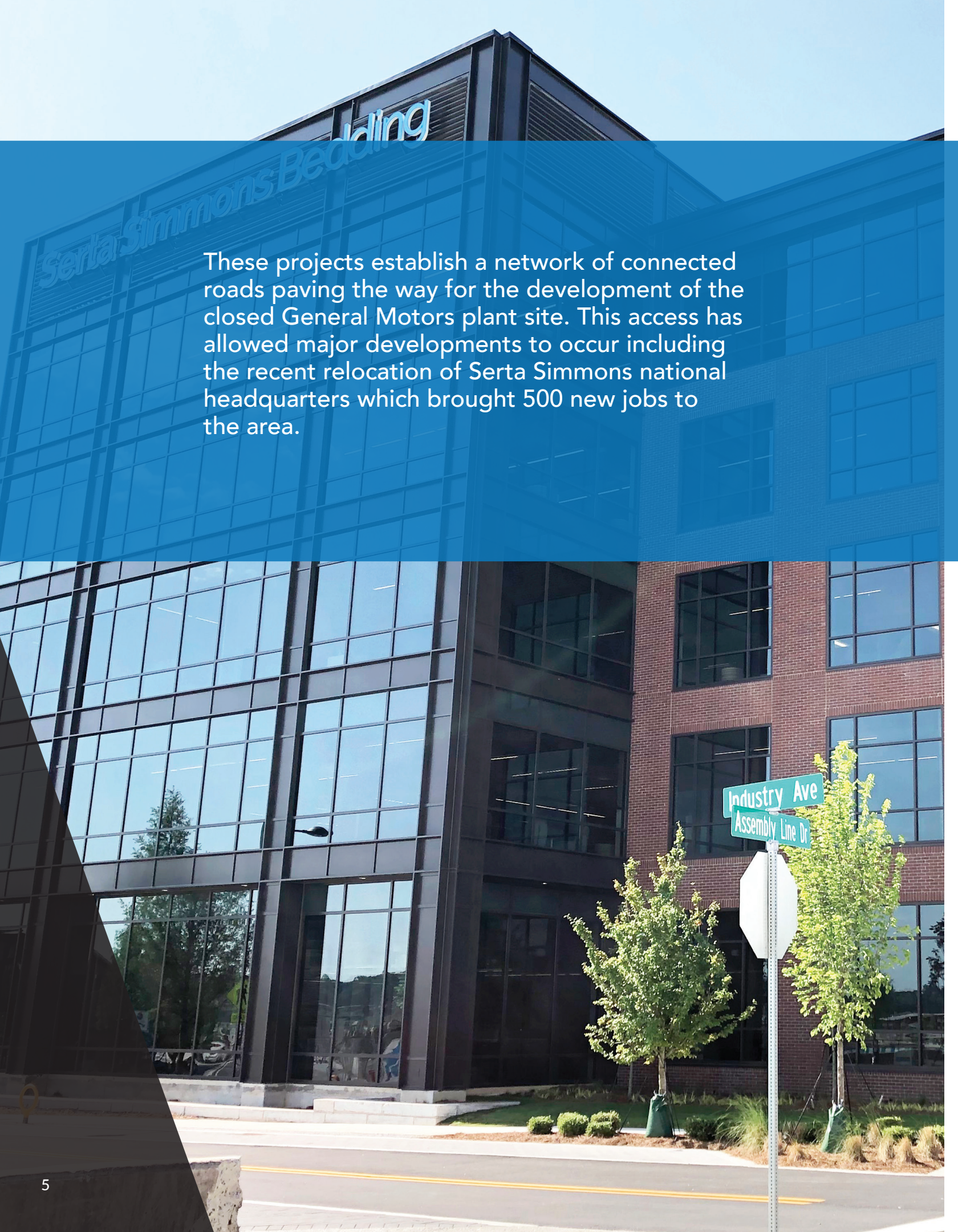

This multi-phase project will improve east-west mobility for vehicular and non-vehicular travel by providing an alternative to South Barrett Parkway. The first two phases are complete and improved intersections, widened existing roads, added a new 4-lane roadway and included a new roundabout. Improvements were also made to bike and pedestrian infrastructure throughout. Phase 3 will complete the project by extending the new roadway over I-75 and will include a second roundabout.





Serta Simmons Bedding

These projects establish a network of connected roads paving the way for the development of the closed General Motors plant site. This access has allowed major developments to occur including the recent relocation of Serta Simmons national headquarters which brought 500 new jobs to the area.

Improvements in downtown Tyrone included the widening and resurfacing of several roads including intersection improvements, the addition of turn lanes and the expansion of sidewalks and ADA improvements. GTIB loans allowed Tyrone to expedite both projects by several years and reduce the overall cost of the project.

This project replaced the bridge over GA 400 with wider travel lanes, new bike lanes and barrier separated sidewalks while making room for future expansions to GA 400 and improving east-west mobility. The project included significant local investment from the CID and the City of Alpharetta along with federal and state funds from GDOT and ARC.

SR 188/CR 320/325 Roundabout Roadway Improvements

Year of Award: 2018

Project Status: Underway

ELIGIBILITY

Who is eligible?

All Georgia counties, cities, community improvement districts (CIDs), state authorities, boards, commissions, agencies and departments are eligible. Two or more of these entities may also apply together.

What is eligible?

Projects must be motor fuel tax eligible. Examples include improvements to public roads and bridges and associated bike, pedestrian and traffic control infrastructure.

GTIB funds may be utilized for preliminary engineering, right of way and/or construction costs.
